



Ohio Educational Library Media Association (OELMA) Awards Program:

OELMA/Follett Library Resources School Librarian-of-the-Year

PURPOSE

The OELMA/Follett Library Resources School Librarian-of-the-Year Award recognizes an Ohio certified library media specialist, who develops an exemplary school library program, collaborates with classroom teachers, implements technology-integrated instruction, demonstrates educational leadership, and advocates for school libraries.

THE AWARD

This Award is sponsored by Follett Library Resources, which provides a \$ 150 stipend and commemorative plaque for the recipient. The Award honoree will be recognized during OELMA's Awards Luncheon at Annual Conference. The Award recipient's name will be posted on the Scholarship & Awards section of OELMA's Web page and announced via OELMA's E-mail list.

SELECTION PROCEDURE

OELMA's Scholarship & Awards Committee is charged with reviewing applications for all Association awards. The Scholarship and Awards Committee is comprised of a representative from each OELMA Region, the Immediate Past President, and the Scholarship and Awards Chair, who is appointed by the President. Although this Committee makes award recommendations, OELMA's Board of Directors makes the final decision at the May Board meeting.

SELECTION CRITERIA

The OELMA/Follett School Librarian-of-the-Year Award recipient will be selected from nominees who meet the following criteria:

- OELMA membership for the previous five years;
- An Ohio certified library media specialist, who has developed an exemplary school library program;
- Demonstrates notable performance in the following areas: classroom teacher collaboration; educational leadership; technology-integrated instruction; and school library advocacy; and
- Demonstrates outstanding performance in at least one of the above-listed areas.

APPLICATION PROCEDURE

Application packets should include the following materials:

- Completed OELMA Scholarship & Awards Program Application Form ;
- Nomination letter, which explains how the nominee meets award selection criteria;
- Career-related details (e.g. resume), including the following: current and previous professional positions; education; professional organizations and offices held; outstanding achievements; honors and awards; and
- At least one – and no more than three – letters of support providing specific evidence of the nominee's collaboration with classroom teachers, implementation of technology-integrated instruction, educational leadership, and school library advocacy.

All application materials must be submitted to the OELMA Office in a single packet. The following three submission methods may be used:

- **Hand-deliver the Awards submission materials to the OELMA Office by 5 p.m. April 15;**
- **Mail the Awards submission materials, which must be postmarked by 5 p.m. April 15; or**
- **E-mail the Awards submission materials to kate@assnoffices.com by 5 p.m. April 15.**
Submission materials MUST be attached to the email as a single .pdf file.

Late materials will not be accepted.
